Ferrer i Guàrdia: an unfair sentence that democracy must redress

Born in Alella, Francesc Ferrer i Guàrdia was executed by firing squad in Santa Eulàlia moat at Montjuïc Castle in 1909, after having been tried in a court martial with no guaranteed rights and sentenced on the basis of a **false accusation**: of having instigated the revolt of Tragic Week, or Setmana Tràgica as it is known in Catalan. More than a century later, the sentence still stands. It has not been reversed or rectified. It is time to put an end to this **historical injustice**.

Ferrer i Guàrdia was the founder of the Modern School, or Escola Moderna, an **educational project** posited on reason, science, coeducation of the sexes and regardless of social classes, and critical thinking. He defended a secular education that broke the chains of ignorance, dogmas and submission as a tool of collective emancipation. The elite of the time would not stand for it. **The trial** was marked by a **campaign of repression** by the political, religious and media sectors. Through his sentence, the authorities of the time sought to quash a model that questioned the established order. His **execution**, however, was condemned internationally as a clear injustice, with protests around the world in cities such as Paris, London, New York, Brussels and Buenos Aires.

He has received no **institutional recognition** since then. This silence not only perpetuates impunity but negates the possibility of creating a memory based on **truth, justice and reparation**. Reversing his sentence is not just an act of historical justice: it is an essential step towards strengthening our democracy.

We therefore demand:

- 1. Reversal of the death sentence of Francesc Ferrer i Guàrdia**, rendering it legally null and void.
- 2. Public and institutional recognition of his educational, humanist and libertarian** legacy as an international reference in secular, critical and universal education.
- 3. The acceptance of responsibilities by the institutions**, consistent with the principles of truth, justice and reparation that must govern all policies regarding democratic memory.
- 4. The promotion of symbolic, educational and memorialistic** measures of reparation, including institutional acts, forums for collective memory and teaching materials.
- 5. The inclusion of the Ferrer i Guàrdia case in public policies of collective memory.**
